# TERMS AND CONDITIONS FOR PARTICIPATION

In these Conditions the term "Exhibitor" means the signatory of this application and includes all employees or agent of such and the term "Organiser" means Global Infocom Ltd.

## 1. PARTICIPATION APPLICATION

All application for participation should be made in the prescribed form. Submission of this form will be to confirm participation and acceptance of the terms and conditions. The organizer reserves the right to accept or refuse any application without assigning any reason for the same. The application shall be submitted to the organizer accompanied by the required payment/ deposit as per enclosed annexure. The application and confirmation of its receipt do not constitute grounds for any claim to approval, or to any specific location or site of stand, in particular the organizer is entitled to implement reeducation in the number of square meters applied for in the exhibition area, if it is oversubscribed.

## 2. STALL ALLOTMENT:

Location will be allocated to meet the exhibitor's preference to the extent possible. However, the organizer reserves the right to change the location allotted to the exhibitor at any time prior to the commencement of the exhibition. The decision of the organizer shall be final and binding on the exhibitor. If, 6 hours before the time at which the exhibition is opened to the public, the exhibitor has not taken possession of the stand space allocated to him or if it has been definitely established before that time that the exhibitor will not avail himself of the space allocated to him/her, or if he has failed to fulfill his financial obligations with regard to the exhibition the organizers may dispose of the relevant stand space without any additional summons or notice of default, without the organizers having to refund payments already received as a consequence being discharged from his obligation to pay the amounts due. The exhibitor may not assign, sublet or grant licenses in respect of any part of the space allotted to it without prior permission of the organizer nor may it display advertisements of firms who are not bonafide exhibitors. Only those products, services and companies mentioned on the application form may be incorporated in the stand. As a special case, the organizer reserves the right to levy a sub-letting surcharge for each sublet a agreed to and the applicant is liable for the payments of this charges under the same terms of payments as the main stand rental.

## 3. PAYMENT TERMS:

Rental charges/ payment/ deposit is a pre-requisite condition for the exhibitor's participation in the exhibition and the use of the stand/ booth payment plan as per enclosed annexure.

## 4. DEFAULT OF PAYMENT:

In case exhibitor fails to make the payment by the stipulated date, the exhibitor's application will be cancelled and 50% of the deposit will be forfeited; and the organizer shall reserve the right to claim all payment due from the defaulting exhibitor. If a exhibitor has failed to meet his obligations towards the organizers in respect of the exhibition, the organizer may with a view to promoting payment of outstanding debts, without recourse to a court of law, take possession of any goods belonging to the defaulting exhibitor that may be present in the exhibition building or have them stored at the expense and risk of the exhibitor concerned. Delegate the collection of the amount owed by the exhibitor to a third party and charge to the exhibitor any extra judicial costs incurred according to standard rates, with a minimum of Rs. 10,000/- (Ten Thousand Only) exclusive of applicable taxes. Will charges interest at a rate of SBI PLR + 5% over the amounts due from the due date of the invoice. The exhibitor shall not be entitled to any form of compensation whatsoever, whether for loss profits or otherwise.

## 5. DATES, AREA, LAYOUT OF STALLS:

The organizer reserves the right to change the venue, dates and timing of the exhibition and the layout of the floor plan.

## 6. STORAGE OPTIONS:

There would be no storage space available prior to opening of the exhibition or after closing of the exhibition. During the exhibition days, storage will have to be done within the respective stalls of the exhibitors. Any goods belonging to exhibitors and any stand components remaining on the premises of the exhibition building or on the adjacent grounds may be stored at the expense and risk of the exhibitor concerned.

## 7. BASIC STRUCTURE:

The basic structure of each stall will be provided by the organizer as mentioned on the front page of this brochure, non-utilization of part or full facility of basic structure provide, will not entail an exhibitor to any refund. Additional requirements by the exhibitors will be provided at extra cost, The cost of construction and fitting-out of stand, installation of electric wiring, connection for gas, water drainage and telephone calls and all other additional costs will be charged immediately to the exhibitor unless otherwise stipulated in the conditions of participation. The organizer will not be responsible for providing stabilized power. Exhibitors are required to take suitable measures to safeguards their equipment against power fluctuations.

## 8. CHANGE IN TERM AND CONDITIONS:

The organizers may change part of the terms and conditions, or add new ones, for the benefit of the exhibition in such a case, a written notice will be sent to all exhibitors. Whenever necessary to ensure the smooth management of the exhibition, the organizer shall have the right to issue supplementary regulations and instructions. All such additional instructions in written form will be a part of the terms and condition for participation and be binding on all exhibitors. In the event of any occurrences not foreseen in these terms and condition for participation, the decision of the organizer shall be final and binding.

## 10. WITHDRAWALS

The exhibitor will not be permitted to withdraw or cancel or alter or reduce in any way their booking of the booth/ stand.

## 11. TRANSPORTATION OF EXHIBITS:

The exhibitor shall bear the responsibility and expenses for the transport of exhibits to the exhibition venue. The exhibitors shall make their own arrangements for the storage and warehousing of the exhibits to the organizer at least ten days prior to the start of the exhibition. No exhibits or other goods will be permitted out of the exhibition venue.

## 12. SECURITY & INSURANCE:

The organizer, its directors, trustees, officials, employees, agents and representatives will not be responsible for the safety of articles of any kind brought into the exhibition by the exhibitor by the exhibitors, their employees agents or contractors, member of public or any person whatsoever. During all periods, security of exhibits, stands and furniture is wholly the responsibility of the exhibitor, his agent or contractor. Exhibitor shall ensure that they are fully covered by insurance and take out public liability and comprehensive protection. The period of insurance shall be from the time the exhibitor first enters the exhibition hall until all his exhibits have been properly removed to the satisfaction of the organizer.

## 13. DAMAGE TO THE VENUE:

The exhibitor shall take good care of and shall not cause any damages or permit or suffer any damages to be done to the exhibition venue or to any part or parts thereof or to any fittings, equipment or other property therein, and shall make good or pay for damages thereto (including accident damage and damage by fire) cause by act or omission of himself, employees co-exhibitors, agents, representatives, contractors or persons by reason of the use of the exhibition venue by exhibitor. If the organizer so damage the exhibitor shall insure the venue for any damage and sand the insurance documents to the organizer, At the end of the exhibition the exhibitors shall leave the stand space allocated to them in the same condition, as it was when it was made available to them before the commencement of the period of construction.

## 14. COMPLIANCE WITH LAWS:

Exhibitors shall comply with all the rules, regulation and laws imposed or laid down by managers of the exhibition venue for all purposes concerned with the implementation of these regulations, and stipulation lay down. Without prejudice to the powers of the parties to enter into a general or limited arbitration agreement, all disputes arising from the exhibitor's participation, from the enforce of these regulations, or from any other contracts relating to the exhibition, including the terms and condition for participation stated herein, or by virtue of regulations or stipulations laid down or will be prescribed by the organizer, shall be governed and construed accordingly and the exhibitor hereby submits to the nonexclusive jurisdiction of the courts, Where a dispute shall arise concerning interpretation of the English text of these terms and conditions for participation shall be deemed to be final. All disputes subject to Delhi jurisdiction.

## 15. INFRINGEMENT OF TERMS CONDITIONS:

The infringement of the above mentioned terms & condition for participation & any other further rules & regulation determined by the organizer result in the exclusion of the exhibitor from the event, and the exhibitor shall have no right to claim compensation or demand refund on any payment already proceeded, loss or expenses, nor shall the exhibitor be released from their contractual obligation to pay. The organizer will have the right to take the following actions in addition to the above mentioned, without proof of default and without intervention of a court, at the exhibitor's expense against a exhibitor who acts in contravention of any provision of the condition of participation, the general rules the guidelines fire safety regulation and/or who does not comply with directions given by the organizer refuse admission to the exhibition and the exhibition building with immediate effect, have their stand closed and /or cleared, keep possession of the goods displayed and of anything built or fitted by exhibitor, without the exhibitor asserting a right to any refund of damage.

## 16. EXHIBITS:

Only products and services, which at the sole discretion of the organizer, are deemed in accordance with the purpose and concept of the show, may be exhibited. No construction / demonstration activates will be allowed outside the stall provided to the exhibitors. If such work is done outside the allotted space, the organizers at the exhibitor's risk & will dismantle the same or extra coverage would be charged. Exhibitors are reminded not to place stickers; signs or poster anywhere in the hall other than within their own stand Likewise, exhibitor's representative(s) may not distribute brochures, invitations etc. along the gangways or near the entrances. This is unfair to other exhibitors and an inconvenience to visitors. No equipment can be operated which makes excessive noise or cause electrical interference or annoyance to other exhibitor. In this matter the decision of the organizers will be final. All logos/ materials, brands displayed at the exhibition by the exhibitor will be the sole responsibility of the exhibitor for any permission to be sought from the respective brand owners & any losses incurred due to issues related to right & permission would be the sole responsibility of the exhibitor to sell his products/ services at the exhibition, however booking of the goods allowed.
